## 1. Introduction

This Cookie Policy explains how Screen Studio ("we", "our", or "us") uses cookies and similar technologies to recognize you when you visit our website or use our application. We are committed to protecting your privacy and giving you control over your data. This policy explains what cookies are, which ones we use, and how you can manage your preferences.

## 2. What are cookies and similar technologies?

Cookies are small text files that websites place on your device to store information. They help websites remember your preferences, understand how you use the site, and provide a better experience. Cookies can be:

- **Session cookies:** Deleted when you close your browser
- **Persistent cookies:** Remain on your device until they expire or you delete them
- **First-party cookies:** Set by the website you're visiting
- **Third-party cookies:** Set by other services the website uses

## 3. How We Use Cookies

We use cookies and similar technologies for:

**3.1. Essential Operations:** Keeping you logged in, remembering your preferences

**3.2 Analytics:** Understanding how visitors use our website (in a privacy-friendly way)

**3.3 Functionality:** Enabling features like feedback submission and user authentication

## 4. Cookies We Use

### 4.1. Essential Cookies

#### What are essential cookies and can I decline them?

These cookies are necessary for our website to function properly. They cannot be disabled without significantly impacting your use of the site.

### 4.2. Functional Cookies

These cookies enable enhanced functionality and personalization.

### 4.3. Analytics

We use **Plausible Analytics**, a privacy-focused analytics tool that:

- Does not collect any personal data or personally identifiable information (PII) - Does not use cookies for tracking (only for excluding your own visits if you choose)
- Is fully compliant with GDPR, CCPA, and PECR without requiring cookie consent
- Collects only aggregated data including page views, session duration, bounce rate, and referrer information

- All data is aggregated and anonymized

**Optional Exclusion:** If you want to exclude your visits from our analytics:

- Plausible sets ONE optional cookie (plausible\_ignore) only if YOU choose to exclude yourself
- This cookie tells Plausible to ignore your visits
- You can set this at: [screen.studio/privacy/exclude] (if implemented)

**Note:** Blocking all cookies may prevent you from accessing certain features of our website, such as staying logged in or submitting feedback.

### 5.2. Specific Opt-Out

**5.2.1. Analytics:** Since Plausible doesn't use tracking cookies, no opt-out is needed for privacy

**5.2.2. Essential Cookies:** Cannot be disabled while using our service

We use cookies based on:

- **Legitimate interests** (GDPR Art. 6(1)(f)): For essential cookies that enable our service to function
